TERMS AND CONDITIONS

- 1. CONDITION OF TERMS AS INDICATED:**
 - A) THE “OWNER” IS EXCLUSIVE BRIDAL HIRE AND GIFTS.**
 - B) THE “HIRER” IS THE PERSONS, COMPANY OR GROUP HIRING GOODS FROM “EXCLUSIVE BRIDAL HIRE AND GIFTS”.**
 - C) THE “GOODS” REFERS TO ALL EQUIPMENT AND ACCESSORIES TAKEN BY THE HIRER.**
- 2. UPON CONFIRMATION OF THE HIRE, A 20% DEPOSIT IS REQUIRED. THE DEPOSIT IS AN ADDITION TO THE PRICE QUOTED.**
- 3. FULL PAYMENT FOR HIRE IS REQUIRED 1 WEEK PRIOR TO THE HIRE DATE.**
- 4. CANCELLATIONS ARE TO BE NO LESS THAN 21 DAYS PRIOR TO THE HIRE DATE.**
- 5. CANCELLATIONS WITHIN 21 DAYS PRIOR TO THE HIRE DATE, THE DEPOSIT WILL NOT BE REFUNDABLE BUT MAY BE TRANSFERRED TO COVER ANOTHER DATE/MONTH.**
- 6. UPON ACCEPTING THE TERMS AND CONDITIONS SPECIFIED WITHIN THE QUOTATION, FULL RESPONSIBILITY IS ACCEPTED BY YOU, “THE HIRER”.**
- 7. ALL “GOODS” MUST BE DELIVERED AT A SPECIFIED TIME AGREED BY THE “HIRER”.**
- 8. ALL “GOODS” WILL BE PICKED UP AT A SPECIFIED TIME AGREED BY THE “HIRER”.**
- 9. THE DEPOSIT WILL BE REFUNDED AFTER ALL ITEMS HAVE BEEN RETURNED AND CHECKED.**
